



## “POLJA” INDUSTRIAL ZONE

### Basic information on the location

- Type of the zone: greenfield, construction land for industrial use.
- Area: 11.2 hectares (free area: 0,89 hectars, 1 free parcels).
- Ownership: 100% in the ownership of the Municipality of Žepče.
- Starting price of the land (subject to changes): determined by the court expert
- Target activities: metal processing, textile industry, food processing, information technologies, and other clean industries.

### Transport connectedness on the location

- 1 kilometer from the M17 Primary Road leading from Bosanski Šamac (border crossing with Croatia) to Žepče and then to Sarajevo
- 0.5 kilometers from the M17.1. Primary Road leading on the route Žepče–Zavidovići–Tuzla.
- 0.1 kilometers from the Railway on the route Budapest–Bosanski Šamac–Sarajevo–Ploče (port).
- 2 kilometers from the future Pan–European Corridor Vc.
- 0.5 kilometers from the future Tuzla–Žepče–Sarajevo Highway.
- 0.5 kilometers from the center of the town.



### Infrastructure

- Road: Yes, access road and road constructed to each of the parcels.
- Power: Yes, high voltage electricity, TS 10(20) 0.4 kV, 2x630 kVA.
- Water supply: Yes, drinking / technological water, pipes with diameter of  $\varnothing 100$ ).
- Sanitation: Yes, for waste water and precipitation water (pipes with diameter ranging from  $\varnothing 200$  to  $\varnothing 600$ ), access to wastewater purification plans.
- Solid waste collection: Yes.
- Telephone / internet: Yes, telephone switchboard with 100 connections.
- District heating: No.
- Gas: No

## Advantages

- Municipality subsidy on the level of lease and the fee for regulation of construction land in the “Polja” Industrial Zone is 75% of the total amount (now collectively they amount to BAM 7.93 / m<sup>2</sup> of the facility).
- Municipal subsidy in the case of construction of renewable energy sources – solar power plant, the amount of the rent is reduced by 50% compared to the amount obtained by the calculation prescribed in paragraph 1 of Article 38 (Decision on amending and supplementing the Decision on construction land, Official Gazette of the Municipality of Žepče no: 7/10 and 8/14).
- Fast issuance of the construction permit – within the timeframe of 3 days (pending all necessary documentation).
- Functional Center for Investors of the Municipality of Žepče based on the “one stop shop service” principle
- Functional Center for Construction Permit Issuance of the Municipality of Žepče.

## Existing investors in the Zone

- **Prevent Žepče d.o.o. (Bosna i Hercegovina)** – textile industry. The main product of the company are leather and textile upholstery for auto-seat brands such as Volkswagen and Audi. The zone has been present since 2013.
- **Jifeng Automotive Interior BH d.o.o. (Germany)** –textile industry. The company is engaged in the production of interior parts for cars of brands such as: BMW, Audi, VW, Daimler – Mercedes, Škoda, and they specialize in the production of leather headrests and armrests. It has been operating in the municipality of Žepče since 2018, and has been present in the zone since 2020.
- **Eagle techlonogy (Norway)** – metal processing industry. The company deals with engineering and manufacturing of cooling systems for ships, off-shore and industrial installations. Active in the zone since 2014.
- **Fastco d.o.o Žepče (Bosna i Hercegovina)** – Wood processing – Production of raw material for furniture and production of boxspring beds without mattress production. In the zone since 2017.
